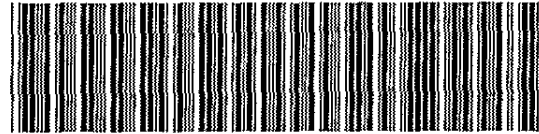

ARTICLES OF INCORPORATION OF CIRCULO DE PROFESIONALES, INC.

The undersigned incorporator for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

Article I NAME

The name of the Not for Profit Corporation being formed shall be that of **CIRCULO DE PROFESIONALES, INC.**

Article II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

Article III PURPOSES

The specific purposes for which this Not for Profit Corporation is organized, is to maintain, promote, sustain and develop activities required or necessary for the recovery and establishment of viable economic industrial activities in the Island of Cuba once a full democratic government returns to that island nation. This mission shall consist of guidelines, conclusions and recommendations presented to the proper authorities, entities and individuals in a position to implement the restoration of the Cuban industry. To that effect the corporation shall prepare feasibility studies, brochures, videos, pamphlets, and other media to create the conditions necessary as heretofore set forth.

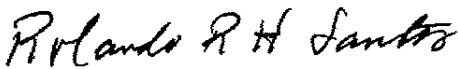
