ARTICLE I

NAME

ARTICLE IV

NATURE OF BUSINESS

- (4) To preach the Gospel of our Lord Jesus Christ and undertake evangelical works in accordance with our apostolic mission and obligations;
- (5) To establish churches or other places of christian worship in either the Anglo-Catholic or Ecumenical traditions and styles of worship and to administer Sacramental Rites in accordance with the member's individual religious office or faculties;
- (6) To undertake other ministries, Christian works or any other matters as directed by the Presiding Abbot of the Society of St. Michael International, Inc. in accordance with Benedictine vows and traditions of obedience.

INITIAL REGISTERED AGENT AND OFFICE




