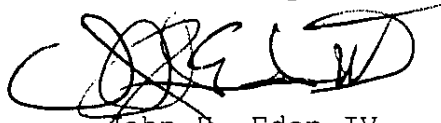

Pursuant to the provisions of Section 617.1006 of the Florida Non-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The Articles of Incorporation were filed on October 23, 2006.

2. The Articles of Incorporation are being amended to change the name of the Corporation and to change the Corporation's principal place of business.

NOW THEREFORE,

3. ARTICLE I is hereby amended as follows:

ARTICLE I - NAME

The name of the corporation shall now be known as, **CITRUS VINEYARD COMMUNITY CHURCH, INC.** The Corporation shall be referred to in this instrument as the "Corporation"; the Articles of Incorporation shall be referred to as the "Articles"; and the Bylaws of the Corporation shall be referred to as the "Bylaws".

4. ARTICLE II is hereby amended as follows:
