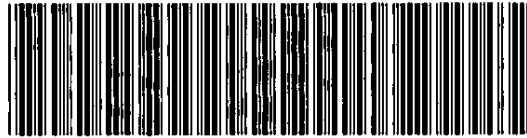

**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION  
OF  
CITRUS VINEYARD COMMUNITY CHURCH, INC.**

Pursuant to the provisions of Section 617.1006 of the Florida Non-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The Articles of Incorporation were filed on October 23, 2006 and revised June 19, 2008.
2. The Articles of Incorporation are being amended to change the name of the Corporation.

NOW THEREFORE,

3. ARTICLE I is hereby amended as follows:

**ARTICLE I - NAME**

The name of the corporation shall now be known as, NATURE COAST VINEYARD CHURCH OF INVERNESS, INC. The Corporation shall be referred to in this instrument as the "Corporation"; the Articles of Incorporation shall be referred to as the "Articles"; and the Bylaws of the Corporation shall be referred to as the "Bylaws".

4. ARTICLE II is hereby amended as follows:

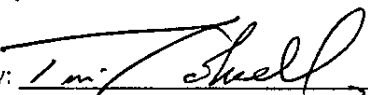
7. ARTICLE VIII is hereby amended as follows:
