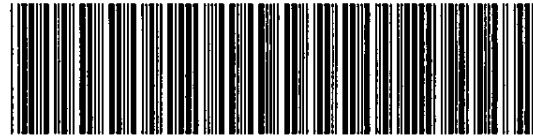

Pursuant to Section 617.1403 of the Florida Statutes, this Florida not-for-profit corporation submits the following Articles of Dissolution:

Article I

The name of the corporation as currently filed with the Florida Department of State is INTENTIONAL MOTHERHOOD, INC. (the "Corporation").

Article II

The document number of the Company with the Florida Department of State is N06000011061.

Article III

The Corporation has no members or members entitled to vote on the dissolution.

The date of the adoption of the resolution by the Board of Directors was November 1, 2011.

The number of directors in office was 7 and the vote for resolution was unanimous.

The original file date of the Articles of Incorporation for the Company was October 23, 2006 (i.e. June 25, 1997).

Article IV

The effective date of the dissolution is December 31, 2011.

Upon written consent and resolution duly made on November 1, 2011, the Board of Directors authorized the dissolution of the Corporation.
