ARTICLES OF INCORPORATION OF PARKWAY MOBILE HOME COURT ASSOCIATION, INC.

The undersigned incorporators, desiring to form a corporation, not for profit under Chapter 723. Florida Statutes, as amended, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation is PARKWAY MOBILE HOME COURT ASSOCIATION, INC. 6206 Buchanan St

Hollywood, FL 33024

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The purpose of the association is to represent the mobile home owners and allow for the exercise the rights provided in Chapter 723, Florida Statutes, as amended and those set forth in the Declaration of Restrictions for PARKWAY MOBILE HOME COURT ASSOCIATION, INC., to be recorded in the Broward County Public Records.

The Association is not organized for profit and no part of the net earnings, if any, shall inure to the benefit of any member.

ARTICLE IV

The Association shall have all of the common laws and statutory powers set forth in Chapter 617, Florida Statutes for a corporation, not for profit and Chapter 723, Florida Statutes for mobile home parks, including the following:

- 1. The power to negotiate for, acquire, and operate the mobile home park on behalf of the mobile home owners;
- 2. For the conversion of the mobile home park once acquired to a condominium, a cooperative, or a subdivision form of ownership, or another type of ownership.

ARTICLE V

The corporation shall not have or issue shares of stock.

Members of the corporation shall be limited to mobile home owners in the PARKWAY MOBILE HOME COURT park located in Hollywood, Broward County, Florida.

ARTICLE VII

The directors shall be elected as stated in the By-Laws of the corporation.

ARTICLE VIII
