ARTICLE ONE: Name

The name of the Corporation is SEWALL'S POINT CITIZENS FOR GOOD GOVERNMENT, INC.

ARTICLE TWO: Duration

The term of existence of the Corporation is perpetual.

ARTICLE THREE: Purpose

The Corporation is organized in order to engage in any lawful purposes not for pecuniary profit. The primary objective of the Corporation is to educate and inform the residents of the Town of Sewall's Point on town issues.

ARTICLE FOUR: Registered Agent Information

ARTICLE TWELVE: Tax Exemption

The corporation is organized for educational and civic purposes. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) as the Board of Directors shall determine.
