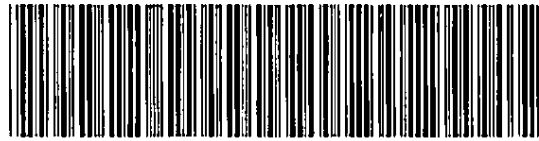

**2-DELIVERANCE BY FAITH** is one of the biggest branches of New Horizon 4 Youth and Families, which is a nonprofit international organization recognized by the state of Florida and that operates in the States Unis and in Haiti.

Establish new churches and supervise the current ones, coordinate worship services, organize mission trips, crusades, missionary tours, seminars, fasting services, and other activities enabling them to live better and for the progress of the Kingdom of God

**Mission:** Promote the establishment of a prosperous christian community.

### **3-Health – Care of Health « Key of life. »**

**Objective:** This is a branch of the organization that is designed not only to provide education and preventive treatment of diseases such as cancer and AIDS but also will aim for setting up structures such as hospital complexes, health centers, teaching hospitals or even community pharmacies and medical laboratories etc.

**Vision:** Bringing progress and prosperity by health. A population in good health will be strong and prosperous.

**Its mission** –Providing preventive and curative treatment. Taking care of all social categories, notably the most underprivileged individuals.

**4- Youth Training and Education.** **Objective:** A well-formed and well educated youth is a good asset for future. With a galloping demography, soon of 15 million inhabitants, Haiti will find it difficult to face the obligation to properly train and educate the youth due to professional insufficiency, training centers and schools of the three levels of education. To reduce this insufficiency, New Horizon 4 Youth and Families Haiti decided to create this branch to contribute to the training and education of the Haitian youth.

**Vision:** Take charge today of tomorrow's women and men to help in the development of this country.

**Its mission:** Establish schools, professional training centers, and universities, wherever there is a need.



**5-Habitat for all. Objective:** Before the seism, Haiti was facing a particular issue related to housing shortage without emphasizing on the quality. But, from the seism, this crisis of accommodation became more evident. Today, many families of the middle class and those from the underprivileged class category live in houses with no comfort, no running water, nor electricity.

**Vision:** Allowing these families to live in a better environment so they can grow, develop, and prosper, especially the youngest ones.

**Mission:** Build houses and provide accommodation for those who are homeless and some families that are unable to regain a financial stability after the seism.

**6-Agricultural Relaunch – Objective:** The sector of agriculture should be the backbone of the economy of our country, which is based primarily on farming and gardening. However, agriculture had been neglected for too long or not being considered as the pillar to rebound its economy.

Nowadays, they import even the food supplies, fruits and vegetables, what makes the needle of the trade balance very inactive. Local fishing professionals do not aquatic resources. The stock becomes thinner, very few per square kilometer. The vast majority of the population is undernourished or uses neither meat, nor fish, for being unable to buy them. A lot of crops perish, due to lack of means to transport or to transform them. The agro-industry is not much developed in Haiti. All this insufficiency reinforces New Horizon 4 Youth and Families in the determination to take part actively in the revitalization of agricultural activities.

**Vision:** Encourage agricultural activities to enhance national productions. Reduce the country's dependency on other foreign countries regarding agriculture.

**Mission:** Set up all technical strategies, tillage, and financial to restart agricultural production. Develop fishing, animal breeding and establish factory for food transformation.

With these six segments of activities, New Horizon 4 Youth and Families fills the act of faith perfectly to contribute to the fundamental needs of the population that will enable them to face more efficiently the numerous challenges of the daily life.

## **F- Additional Articles:**

### **5-Administration / operations**

Every aforementioned department will be managed by an Executive committee of 5 - 7 members working under the supervision of the direction of New Horizon 4 Youth and Families Inc. However these departments will have their own internal regulations. We are located at present in the United States of America and in Haiti. But our vocation it is to bring our assistant

anywhere there is a need that compels us as an organization to assist. Every department will have its own Website which will be attached to that of New Horizon 4 Youth and Families Inc.

5.1-Every department will have two meetings with the direction of New Horizon 4 Youth and Families Inc. yearly in order to discuss about their specific activities. The second meeting must take place before the general meeting of New Horizon 4 Youth and Families. The dates of meetings will be determined jointly between both parties.

5.2-The Executive committee will be representatives for planning, for establishment, and for valuation of all activities relating to the functioning of its department.

5.3-The Executive committee will subject all their plans of activities to the members of the direction of New Horizon 4 Youth and Families for valuation and approbation two months before any execution.

5.4-Every Executive committee will choose a sub-committee to facilitate the connection with the direction of New Horizon 4 Youth and Families.

5.5-Every Executive committee has the right to establish its own working agenda in regard to its activities.

5.6-Every Executive committee has the right to determine its own financial means. However, as for other activities, the direction of New Horizon 4 Youth and Families Inc. will always have the last word.

6-Members: Every department has enough places to receive and supervise their members.

6.1-Supporters: Those who support this initiative with their own financial means and other contributions

6.2-Beneficiaries: those who want to remain in the circle of the organization to work to fulfill their dreams and who continue to share their testimony to others.

## 7-Financing / Donation

These departments will be financed with generous help and donation of the friends, members or supporters or through other fundraising activities.

7.1-Any forms of donations will be welcome and they will be reimbursed through tax deductible under the 501 (c) (3) status of New Horizon 4 Youth and Families Inc. Individual qualifications will be determined.

7.2-All donations in cash or in kind must be made in the name of New Horizon 4 Youth and Families Inc. with the mention of the name of the specific department.

7.3-The treasury of New Horizon 4 Youth and Families will be considered a fund in general account to be all sums credited to the advantage of every department.

7.4-All funds gathered by sale of services or property will be deposited in the central treasury for the progress of the organization.

7.5-Activities: The list of sub-mentioned activities is not exhaustive. However, other activities can be taken into consideration to the benefit of the recipients in any particular instant.


