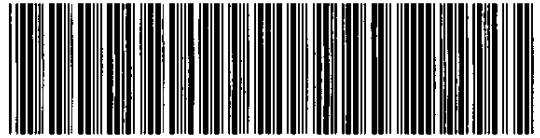

The document number of the Corporation is N06000011223.


Article III


Article IV
