**Articles Of Incorporation Of
Primera Iglesia Bautista De Eustis, Inc.**

The undersigned, for the purpose of forming a nonprofit corporation under the Florida Not For Profit Corporation Act, Florida Statutes, Chapter 617, does hereby make and adopt the following Articles of Incorporation:

**Article I
Name**

The name of the Corporation is "Primera Iglesia Bautista De Eustis, Inc."

**Article II
Not For Profit**

The Corporation is a corporation not for profit as defined by Chapter 617 Florida Statutes. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Directors or Officers, except to the extent permissible under law.

**Article III
Commencement Of Corporate Existence
And Duration**

The Corporation will begin its corporate existence as of the filing of these Articles of Incorporation. The duration (term) of the Corporation is perpetual.

**Article IV
Purposes**

The Corporation is organized, and shall be operated exclusively for, the following purposes:

1. Notwithstanding the any other provision of these articles, said organization is organized exclusively for charitable, religious, and educational purposes within the meaning of § 501 (c) (3) of the Internal Revenue Code, the making of distributions to organizations that qualify as exempt organizations under § 501 (c) (3), or corresponding section of any future federal tax code.
2. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, manage, option, donate or other wise dispose of such property and the income, principal and proceeds of such property, for any of the purposes set forth herein.
3. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them; provided, however, that the corporation

shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code.

Article V Dissolution

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of § 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of, shall be distributed as directed by the Court of Common Pleas (or court of similar jurisdiction) of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article VI Initial Registered Office And Agent And Principal Office Of The Corporation

The mailing address of the corporation is 22100 CR 44A, Eustis, Florida 32736. The principal place of business address of the corporation is 19650 State Road 44 East, Eustis, Florida 32736. The initial registered office address is 22100 CR 44A, Eustis, Florida 32736. The initial registered agent of the Corporation at that address is Evangelina Gonzalez.

Article VII Officers

The Officers of the Corporation shall consist of such Officers and Assistant Officers as may be provided in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws.
