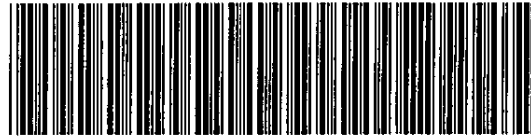

Article V ~ Initial Board of Directors: Elizabeth Cuevas-Neunder, President CEO




