The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida OF STATE Statues, adopts the following Articles of Incorporation for such corporation:

ARTICLE I NAME

The name of the corporation shall be: EGLISE EVANGELIQUE HAITIENNE PRIMITIVE MARANATHA, INC.

ARTICLE II: ADDRESS

Principal place of corporation and mailing address of this corporation shall be: 175 NW 128th Street, North Miami, Florida 33168

ARTICLE III. CORPORATE NATURE

This is a nonprofit corporation organized solely for general educational purpose pursuant to the Florida Statues, Section 617 of the Florida Not For Profit Corporation Act.

ARTICLE IV. DURATION

- (b) The general nature and purposes of this corporation shall be exclusively for religious, charitable within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

ARTICLE VI: MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

All directors must be members of <u>EGLISE EVANGELIQUE HAITIENNE PRIMITIVE MARANATHA, INC.</u>

Their election shall take place at a meeting called for that purpose, of which at least one Week's public notice has been given. An affirmative vote of three fourths of those members Present will validate the choice. The directors shall be replaced or elected for a new term

At the annual election of officers of the corporation.

ARTICLE VII: LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302. Florida statutes Unless limited as follow:

The corporation shall be empowered to enter into contacts, hold and convey title to real and personal property, and exercise all powers permitted a corporation not for profit and the other laws of the state of Florida not inconsistent with the general objectives enumerated herein. All funds of the corporation and any moneys from its operation shall be used in the furtherance of the purpose set forth hereinabove.

No part of the net earnings of the corporation shall insure to the benefit of, or be distributable to, any director or officer of the corporation or ay private individual (except that reasonable compensation may be paid for service rendered to or for corporation in furtherance of one or more of its purpose(s), and no director or officer of the corporation or any private individual shall be entilted to share in the distribution of any of the corporate assets on dissolution of the corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or Intervene in (including le publication or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501 (c) (3) of the Internal Revenue Code and the regulations issued pursuant thereto as the now exist or as they may hereafter be amended, or by an organization, contribution to which are deductible under section 107 (c) (2) of the Internal Revenue code and said regulations as they now exist or as may hereafter be amended.
