ARTICLES OF INCORPORATION

The undersigned incorporator, a natural person 18 years of age or older, in order to form a corporate entity in compliance with Chapter 617, Florida Statutes, adopts the following articles of incorporation.

ARTICLE I – NAME

The name of the corporation shall be **MOUYENGA MINORITY ASSISTANCE INC.**

ARTICLE II - PRINCIPLE OFFICE

The corporation's principle office is located at **2450 East Hillsborough Avenue, Number 1415, Tampa, Florida 33610.**

ARTICLE III – PURPOSE

This corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, the corporation shall provide funds with the purpose of poverty relief through the education of minorities. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE IV – MANNER OF ELECTION

The method of election of directors is as stated in the bylaws.

ARTICLE V – LIMITATIONS

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

1. No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any Director or officer of the corporation, nor to any other private persons, excepting solely such reasonable

compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation;

2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office; and

3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.

ARTICLE VI - DISSOLUTION OF ASSETS

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VII - INITIAL DIRECTORS

The management of the affairs of the corporation shall be vested in the Board of Directors as defined by the corporation's bylaws. No director shall have any right, title or interest in or to any property of the corporation.

The names and addresses of the first directors of the corporation, who shall hold office for the first year, shall be DENIS MOUYENGA, 2450 East Hillsborough Avenue, Number 1415, Tampa, Florida 33610.

ARTICLE VIII - INITIAL REGISTERED AGENT AND STREET ADDRESS
