Articles of Incorporation

Articles of Incorporation of the undersigned, a majority of whom are citizens of the Untied States, desiring to form a Non-Profit Corporation under the Nonprofit Corporation Laws of the State of Florida, do hereby certify:

First: The name of the Corporation shall be Families Exploring Down Syndrome of Brevard, Inc.

Second: The place in this state where the principal office of the Corporation is to be located is the City of Cocoa, Brevard County. The mailing address of the Corporation is 425 Brevard Avenue, Cocoa, Florida 32922.

Third: Said corporation is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501c(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Fourth: The names and addresses of the persons who are the initial trustees of the corporation are as follows: the method of election of directors is as stated in the bylaws.

Sixth: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 c(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
