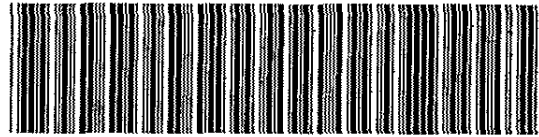

addition to and not exclusive of all other rights to which said director or Officer may be entitled.
