ARTICLES OF INCORPORATION

FOR



Coibhin na Awen, Inc.

A FLORIDA NOT-FOR-PROFIT CORPORATION

The undersigned, acting as the incorporator of Coibhin na Awen, Inc, under Chapter 617, Florida Statutes, and Section 501(C)(3) of the Internal Revenue Code of 1986, submit the following Articles of Incorporation.

ARTICLE I. GENERAL

The name of the corporation shall be: Coibhin na Awen, Inc.

ARTICLE II. ADDRESS

The address of the corporation's physical principal office is 461 W 55 Place, Hialeah, Miami-Dade County, Florida, 33012

ARTICLE III. DURATION AND COMMENCEMENT

The Corporation will exist perpetually, commencing with the filing of these Articles of Incorporation with the Florida Department of State.

ARTICLE IV. PURPOSE

The Corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, including but not limited to developing and fostering practice of pagan and wiccan spiritual beliefs. The purposes of the corporation shall also include the performance of activities related or incidental to the furtherance of the corporation's stated purposes and permitted under the laws of the United States and Florida.

ARTICLE V. PROHIBITED ACTIVITIES

This Corporation shall not engage in any activities prohibited by Section 617.0835 of the Florida Statutes.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office. Not withstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future United states Internal Revenue Law, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, or corresponding section of any future United States Internal Revenue Law.

ARTICLE VI. DIRECTORS

The initial board of directors of the Corporation shall consist of three (3) members. The names and addresses of the members of the Corporation's initial board of directors are:

ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT

VIII. INCORPORATOR

ARTICLE IX. DISSOLUTION

ARTICLE X. AMENDMENTS

The Corporation reserves the rights to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law.
