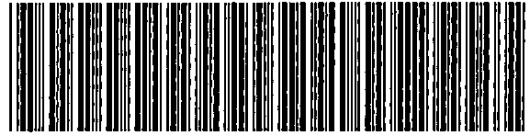

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

Sunshine State Speedskating Club Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

1594 Starfish Street, Kissimmee, Fl. 34744

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The Sunshine State Speedskating Club, a not-for-profit organization developed to assist and educate the young and the community in ice speed skating techniques and styles by promoting healthy lifestyle and developing future athletes and Olympic hopefuls in addition to receiving gifts or donations to encourage welfare and recreation of the general public via the sport of ice speedskating.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

- a) Term of Office. The Directors elected at the annual meeting shall hold office for a period of two (2) years until their successors shall be elected and qualified. Subsequent Directors shall also hold office for a period of two (2) years after the date of his or her election and until a successor has been elected and qualified.
- b) Elections. Election of Directors shall be held at the Annual Meeting of the FOUNDATION. Only those members who have been nominated for election, as a Director in accordance with the procedures herein shall be a candidate. All elections for Directors shall be held by secret written ballot. In the election for Directors, each Director of the FOUNDATION is entitled to vote for as many candidates as there are Directors to be elected (but can not cast more than one vote for any one candidate) and the candidates receiving the heist number of votes shall be elected.
- c) Number of Consecutive Terms. The Directors shall be permitted to remain on the board for consecutive terms.

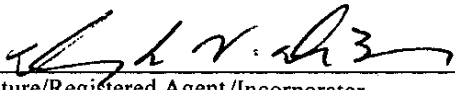
