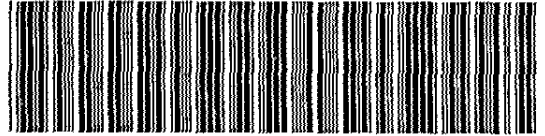

In the last line of the preamble, delete (4) and insert (3) after the words "Section 501 (C)".

Also, make this same change in Article III, Paragraph 8 and Add (3) to the third line Article of
Article IX, after the words "Section 501 (c)", thus reflecting the intent of Floridians For
Recovery, Inc., to be chartered as a Charitable/Educational Association.

In Article II, change the mailing address to be at: 225 West Busch Boulevard,
Tampa, Florida 33612, (i.e., the same as the principal place of business).

In Article III, Paragraph 2, delete the words "victims of" and insert the words
"effected by" after the words "who are".

In Article III, Paragraph 3, insert the phrase "and solutions to" between the words
"of" and "addictions".

In Article IV, Paragraph 3 add the sentence: "A minimum of fifty-five percent
(55%) of the Board members must be "In Recovery" or be a family member of,
or a 'significant other' of a person in recovery."
