ARTICLES OF INCORPORATION

Floridians for Recovery, Inc. (a not-for-profit corporation)

We, the undersigned, with other persons being desirous of forming a corporation authorized to exercise powers permitted non-profit corporations for educational, charitable and philanthropic purposes, under the provisions of Chapter 617 and Chapter 496 of the Florida Statutes: provided however, that this corporation in exercising any one or none of such powers shall do so in furtherance of the exempt purpose for which it has been organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code

ARTICLE IX DISTRIBUTION OF ASSETS ON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
