Articles of Incorporation of

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is to provide physical, spiritual and emotional support to all in need, to promote dignity and self worth of individuals and to practice and encourage good stewardship, to live out and promote the Gospel of Jesus Christ through all our actions.
