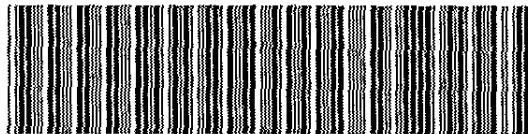



**ARTICLES OF INCORPORATION
OF
GLOBAL SPORTS OUTREACH, INC.
(A Corporation Not for Profit)**

We, the undersigned, with other persons desirous of forming a corporation not for profit, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I - NAME

The name of the corporation is GLOBAL SPORTS OUTREACH, INC.

ARTICLE II - REGISTERED OFFICE AND REGISTERED AGENT
