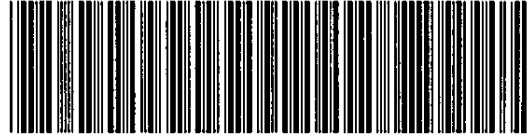

a. Notwithstanding any other provision of this document, the organization

shall not carry on any other activities not permitted to be carried on (a) by
an organization exempt from federal income tax under section 501 (c) 3 of
the Internal Revenue Code, Or corresponding Section of any future

deductible under section 170 (c) (2) of internal Revenue Code, or

Court of Common Pleas of the county in which the principal office of the organization is
then located, exclusively for such purposes or to such organization or organizations
as said Court shall determine, which are organized and operated exclusively for such purposes.

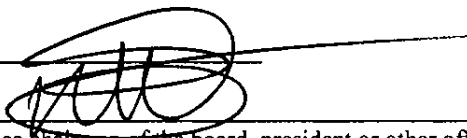
