THE UNDERSIGNED, acting as incorporator of a not-for-profit corporation, pursuant to Chapter 617, Plorida Statutes, hereby adopt the following Articles of Incorporation for such corporation.

#### **ARTICLE I**

#### NAME

The name of the corporation shall be:

HELP US FOUNDATION, INC.

#### ARTICLE II

#### PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

#### <u>ARTICLE III</u>

#### PURPOSE(S)

The general purpose for which the Corporation is formed is to operate exclusively for such educational, cultural and charitable purposes as will qualify it as an exempt organization under Section 501(c)(3) of the luternal R evenue Code of 1986 or corresponding provisions of any subsequent federal tax laws. The Corporation shall not, as a substantial part of its activities, carry on propagands or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statement or otherwise) in any political campaign on behalf of any candidate for public office.

The specific purpose of the Corporation is support of Catholic institutions dedicated to the
