The undersigned, acting as the Incorporator of GOHJA, INC., a Florida not for profit corporation (the "Corporation"), pursuant to Chapter 617 of the Florida Statutes, hereby forms a corporation not for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

ARTICLE I - NAME

The name of the Corporation is GOHJA, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation is 5100 Double R Lane, Oviedo, Florida 32765.

ARTICLE III - PURPOSE

The purpose of the Corporation is to inspire, encourage interest in and regulate equestrian competition in hunter and jumper competitions. It will endeavor to create a better understanding among breeders, owners, and exhibitors of such horses. 
