In compliance with the requirements of F.S. Chapter 617, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is Bay High School Wrestling Boosters, Inc.

The effective date and existence of the Corporation shall begin on the date of filing with the Florida Department of State Division of Corporations, State of Florida. The corporation shall exist perpetually.
