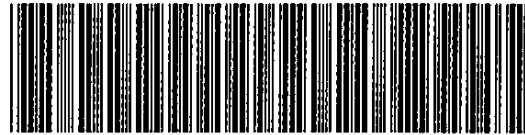

# Articles of Incorporation of Stop the Madness Outreach, Inc. A Florida Non-Profit Corporation

The undersigned, for the purpose of forming a non-profit corporation under the Florida Not-For-Profit-Corporation Act, Florida Statutes 617, do hereby make and adopt the following Articles of Incorporation.

## Article I

The name of the corporation is Stop the Madness Outreach Inc.

## Article II

The address of the principal office and the mailing address of this corporation shall be:

1160 West De Soto Street  
Clermont, Florida 34711

## Article III

Our mission is to provide the at-risk youth of our area a safe environment to grow and learn throughout a drug-free community.

We are here to encourage and promote drug, violence, and crime prevention.

We strive to educate our youth on drug awareness through educational after school programs.

We are building a healthy community to secure successful futures for our at-risk children.

We believe that if we invest in a child we invest in our future.

If we as a community train a child now we won't have to spend time and money later repairing their future.

## Article IV

The specific purposes for which the said corporation is organized are:

- A. The said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations, under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

- B. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in Article Third hereof. No substantial part of activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- C. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
- D. The directors shall be appointed from Lake County Citizens who are actively involved with Stop the Madness Outreach, Inc. projects and directly appointed by the founder in consultation with the Lake County Sheriff, and local city government. The initial directors and officers shall be named at a later date.
- E. To provide a forum before which citizens interested in our mission may express their interests.

- F. To accept donations, gifts, and contributions in money, services, materials or otherwise, from the United States or any of its agencies, or from the State of Florida or any of its agencies, or from others, and to use or expend such monies, services, materials, or from other contributions in carrying on its operations.
- G. To obtain options upon and to acquire by purchase, exchange, lease, gift, grant, bequest, devise or otherwise any property, real or personal, or rights or interest therein.
- H. To maintain, manage, administer, and improve any properties acquired, to receive income from such properties and to expend such income in carrying out the purposes stated herein.
- I. To develop coalitions among like minded organizations.

Article V  
Limitations of Corporate Powers

The corporate powers of this corporation are as provided in section 617 Florida Statutes.
