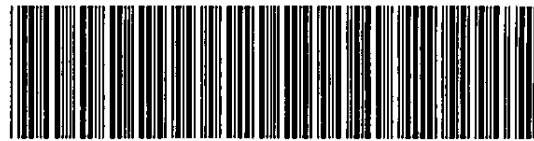

The undersigned, for the purpose of forming a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation shall be:

NEW HORIZON COMMUNITY CHURCH, INC

Clearwater, Fl. 33761
Pinellas County

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

Purpose

Said corporation is organized exclusively for charitable, religious and educational purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future tax code.

ARTICLE IV

Initial Registered Office and Agent

The street address of the initial registered office of the corporation is 3375 Hunt Club Drive, Clearwater, Florida 33761, and the name of its initial registered agent at that address is **CHRISTINE KING**.

ARTICLE V

ARTICLE VI

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision in these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated for such purposes.

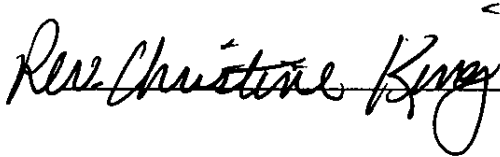
