Article III (amended)- That the purposes for which it is formed are religious,

assist in improving and ameliorating the moral and social conditions of humanity;

to purchase, own, sell, mortogage and lease real estate and other property as may be

necessary for the purposes of this corporation; to recieve donations, to recieve, manage,

take, and hold real and personal property by gift, grant, devise, or bequest, and to sell

or dispose of the same; and to do every thing nesssary, suitable, or proper for the

accomplishment of any of the purposes herein enumerated, or which shall at any time

appear conducive or expedient for the protection or benefit of this corporation.

Article VIII (addition): That it is a corporation which does not contemplate pecuniary gain or profit to the members thereof, and therefore there shall be no capital stock.

Article IX (addition): **Trust Clause:**

“In trust for the use and benefit of the Free Methodist Church of North America, incorporated under the name of ‘The Free Methodist Church of North America,’ subject to the *Book of Discipline*, usages, and ministerial appointments of said church, as from time to time authorized and declared; and, if sold, the proceeds shall be disposed and used in accordance with the provisions of said *Book of Discipline*, and the civil law; and in further trust and confidence that in the houses of worship now constructed or that may here after be constructed on said promises hereby conveyed, the seats shall be forever free; and in further trust and confidence that the said trustees and their successors in office shall permit at all times the preachers who may be duly authorized according to the *Book of Discipline* of the said Free Methodist Church, to hold religious services in said houses of worship according to said *Book of Discipline*.”

Article X (addition)- **Rules and Regulations:**

That said corporation shall be subject to the rules, regulations, and *Book of Discipline* of The Free Methodist Church of North America as from time to time adopted by the General Conference of the Free Methodist Church of north America in so far as the same do not contravene or conflict with the laws of the State of Florida.

The Book of Discipline, rules and regulations of the free Methodist Church as from time to time adopted by the General Conference of The Free Methodist Church of North America shall at all times be a part of the bylaws of this corporation.


