The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

#### **ARTICLE 1 - NAME**

The name of the Corporation is **IGLESIA DE DIOS CAMINO DE SANTIDAD**, **INC.**, (hereinafter "Corporation).

#### **ARTICLE 2 - PURPOSE OF CORPORATION**

The Corporation is organized for the purpose of Facilitating Religious gatherings for church members.

#### **ARTICLE 3 - OFFICERS**

#### **ARTICLE 6 - DIRECTORS**

#### **ARTICLE 7 - TERM OF EXISTENCE**

This Corporation shall have perpetual existence.

#### **ARTICLE 8 - CAPITAL STOCK**

This Corporation shall have no capital stock and shall be composed of members rather than shareholders.

#### **ARTICLE 9 - QUALIFICATIONS OF MEMBERSHIP**

#### **ARTICLE 13 - EFFECTIVE DATE**

These Articles of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.

#### **ARTICLE 14 - AMENDMENT**
