Present Activities

- Tutoring children ages 12-17 years old for purpose of Academic success i.e. Florida Comprehensive Assessment Test (FCAT), SAT/ACT prep course work, Math, Seience English, and Reading and Writing skills.
- The program has been advertised by word of mouth and by varies teachers and Guidance Counselors that have participated or took note of the program in its beginning stage.
