ARTICLES OF INCORPORATION

## Article VIII

## **Dissolution Clause**

On dissolution of the corporation, after paying or providing for the payment of all of the liabilities of the corporation, the corporations assets shall be distributed (1) for one or more exempt purposes with the meaning of IRS 501 ( c ) 3, or the corresponding section of any future federal tax code or (2) to the federal government, or to a state, or local government, for a public purpose. Any assets not disposed of shall be disposed of by the circuit court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations that the court shall determine and that are organized and operated exclusively for such purposes.
