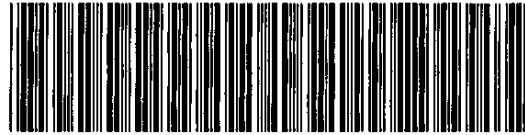

ARTICLE VIII. Purpose.

Besides our goal of spreading the literary works of the Fathers of the Christian Church, The Identity Message and the study of important events in the History of Christianity IN ENGLISH, we'll also work for these goals IN SPANISH as well to help the Cuban people become familiar with these subjects. To this end, we project to send the appropriate literature to Cuba with members of our Academy who will travel to Cuba with this purpose.


ARTICLE IX. In the event of dissolution of this Academy.
