CERTIFICATE OF INCORPORATION

OF

UNION FAMILIA ESCOLAPIA CUBANA, INC.

We undersigned, hereby associated ourselves together for the purpose of becoming a corporation under the laws of the State of Florida by and under the provisions of the statutes of the State of Florida, providing for the formation, rights, privileges, immunities and liabilities of incorporation non for profit.

ARTICLE I

The name of the corporation shall be:

UNION FAMILIA ESCOLAPIA CUBANA, INC.

ARTICLE II

The corporation is organized as a not for profit and nonstock corporation under the laws of the State of Florida and of the United States of America. The corporation shall not be authorized to issue capital stock.

ARTICLE III

This corporation is formed to carry out religious, benevolent, literary and educational purposes, including but not limited to any activity or business permitted under the laws of the State of Florida and of the United States of America.

ARTICLE IV

The existence of the foundation is perpetual.

ARTICLE V

The initial post office address of the principal office of the corporation in the State of Florida is 342 SW 23 Road, Miami, FL 33129-1924.

The Board of Directors may, from time to time, move the principal office to any other address in the State of Florida. The registered address of the corporation is 342 SW 23 Road, Miami, FL 33129-1924. The registered Agent at the registered address is Raul L. Zayas-Bazan.

ARTICLE VI

The business of the foundation shall be managed by a Board of Directors consisting of not less than one (1) nor more than two (2) directors. A quorum for the holding of meetings of the board of directors and for the transaction of any business which will be properly done by the directors on behalf of the foundation shall consist of a majority of the members thereof; but the directors, by unanimous consent in writing, included among the minutes of the foundation, may consent to the doing of any act and such consent in writing shall have the same force and effect as though a formal meeting had been held pursuant to call being duly made and as though the said act had been done and authorized at a meeting at which a quorum had been present, or such duties may be delegated to an Executive Committee.

ARTICLE VII
