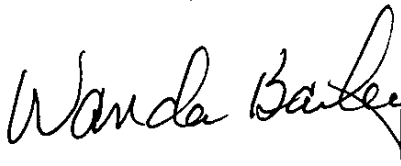

WE, THE UNDERSIGNED, do hereby associate ourselves together for the purpose of forming and becoming a corporation, not for profit, under the laws of the State of Florida, Chapter 617, Florida Statutes (not for Profit), and do hereby certify that we have become such corporation, not for profit, and pursuant to the following Articles of Incorporation.

ARTICLE I: Name of Corporation

The name of the Corporation, not for profit, is First United Methodist Church of Mexico Beach, Inc.

ARTICLE II: Principal Place of Business

The principal place of business of the Corporation is 111A North 22nd Street, Mexico Beach Florida 32410. The principal mailing address is P.O. Box 13652, Mexico Beach, Florida 32410.

ARTICLE III: Purpose of the Corporation

This Corporation is organized as a local United Methodist Church exclusively for religious purposes. The Corporation is organized to support the United Methodist form of Christian worship, mission, and evangelism, operating under the authority of Holy Scripture. It is charitable, educational, and religious in its purpose.

ARTICLE IV Membership

The initial members of the congregation shall be the members of the local church congregation immediately prior to incorporation. Additional members may be added as provided for in the Corporation's By-Laws. Members shall place their names and addresses, or have their names and addresses placed, in a register or file to be kept as prescribed in the Corporation's By-Laws.

ARTICLE V: Effective Date and Duration of Corporation

The effective date of this corporation shall be November 21, 2006 and it shall have perpetual existence.
