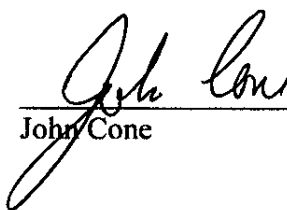

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I

The name of the corporation shall be: BASCA CUSTOM CREATIONS, INC.

ARTICLE II

The principal place of business and mailing address of this corporation shall be:

841 Plainfield Ave, Orange Park, FL 32072

ARTICLE III

The purpose for which the corporation is organized is exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501.C3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. Specifically this corporation will be a design, development, manufacturing and training center for developmentally disabled adults.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501.C3 of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purposes.

ARTICLE IV

The manner in which the directors are elected or appointed are stated in the By-Laws of the corporation.
