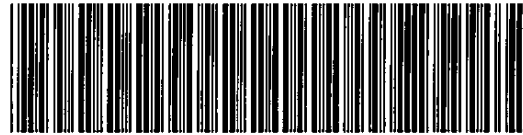

## **ARTICLES OF INCORPORATION**

**In Compliance with Chapter 617, F. S., (Not for Profit)**

### **ARTICLE I NAME**

The name of the corporation shall be:

**GREATER LOVE WORLD MINISTRIES INC.**

### **ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

Tampa, Florida 33634**

### **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

**The corporation is organized and shall be exclusively for the purpose stated and not for profit. No part of the net earnings or income of this church and religious corporation shall (inure) for the benefit of any person or individual.**

**Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.**

**Inclusive with these purposes are the following:**

- A. To preach and teach the gospel of Jesus Christ.**
- B. To carry on the work of Greater Love World Ministries Inc., - a bible believing church in all its spiritual, benevolent, educational, philanthropic, civil and social aspects and activities.**
- C. To promote the spiritual welfare of all people and disseminate the Word of God to the people of all nations in the conformity with the principles of Greater Love World Ministries Inc., Tampa, Florida.**
- D. To accept donations, contributions and gifts of all kinds of property, whether real, personal or mixed, or any interest or estate therein in this state or in any of the states of the US territories or dependencies.**

**Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes with the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for public purpose.**

**ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

Election or appointment of directors shall take place annually by the first meeting of the corporation's calendar year.

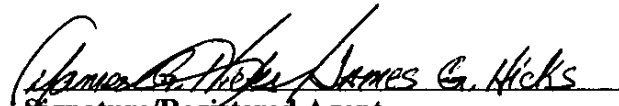
