- (b) Upon the dissolution of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation shall be distributed to a non-profit fund, foundation, or corporation, which is organized and operated exclusively for public benefit or religious purposes as under Section 501 (c)(3) of the Internal revenue Code, or the corresponding provision of any future United States Internal revenue Law. Any such assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
