A NONPROFIT CORPORATION

The undersigned, natural person of the age of eighteen years or older, acting as incorporal the purpose of creating a nonprofit corporation under the laws of the State of Florida in compliance with Chapter 617, F.S., do hereby set forth:

- Article I The name of the corporation is **Covenant Wealth Ministries, Inc.**
- Article II The principal place of business and mailing address of this corporation is: 7441 Biltmore Dr., Sarasota, FL 34231
- Article III The purposes for which the corporation is organized are:
  - a. <u>Covenant Wealth Ministries, Inc.</u> organized for exclusively religious, chareducational and scientific purposes within the meaning of Section 501(c)(3) of Internal Revenue Code of 1986 or the corresponding provision of any future I States Internal Revenue Law, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under said Section 501(c)(3) of the Internal Revenue Code of 1986.
