ADDENDUM "A"

Article III Purpose

The purpose is to operate exclusively within the meaning of Section 501(3)(c) of the Internal Revenue Service Code of 1986, for charitable, scientific and educational purposes. More Specifically, to support the Guardian Ad Litem program for children in need as they move through the court system, raise awareness of children's issues to include but not be limited to, victimized children, children in need of emotional direction as they enter and go through the court process. No part of the net earnings of this corporation shall be distributed to or inure to the benefit of any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation to effect one or more of it's purposes).
