OF

In compliance with the requirements of Chapter 617 (Not for Profit), Florida Statutes, the undersigned, being natural persons, do hereby act as an incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a not for profit business corporation under the Florida Business Corporation Act.

**ARTICLE I
NAME**

**ARTICLE II
PRINCIPAL OFFICE**

**ARTICLE III
PURPOSE**

The purpose of this corporation is the prevention and extinguishment of fire and the protection of life and property in case of fire and other emergencies.

**ARTICLE IV

MANNER OF ELECTION**

The incorporators appointed an interim Board of Directors who shall serve until the first annual meeting in January of 2007. The interim board of directors have been approved to serve as the initial Board of Directors pending approval of the membership at the annual meeting. The Board will meet annually on the second Tuesday of January each year to elect or reelect directors. Minutes of said meetings will be filed in the secretary's books and shall become a part of the


