

Amendment to the FPCA Education Foundation articles, in order to change and amend Article V, Distribution of Assets on Dissolution as originally filed with the Department of State on December 15, 2006.

Wording as originally filled:

In the event the Corporation dissolves, the Board of Directors shall, after paying or making provisions  
for the payment of all of the liabilities of this Corporation, distribute all remaining assets of this Corporation  
exclusively to "charitable organizations," as described herein, or should be distributed to the federal,  
state, or local governments for one or more public purposes. Any such assets not so disposed of shall  
be disposed of by a court of competent jurisdiction in the county in which the principal office of the Corporation  
is then located, exclusively for one or more exempt or public purposes.

Amended wording as approved by Board vote on January 15, 2009:

Upon winding up and dissolution of this corporation, after paying or adequately providing  
for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit  
fund, foundation, or corporation which is organized and operated exclusively for charitable, educational,  
religious, and scientific purposes and which has established its tax exempt status under Section 501(c)(3)  
of the Internal Revenue Code.
