ARTICLES OF INCORPORATION OF THE UNDERSIGNED, A MAJORITY OF WHOM ARE CITIZENS OF THE UNITED STATES, DESIRING TO FORM A NON-PROFIT CORPORATION LAW OF REDLAND EVENING HERBAL SOCIETY, CORP., DO HERBBY CERTIFY:

### ARTICLE 1. NAME

THE NAME OF THE CORPORATION SHALL BE <u>REDLAND EVENING HERBAL</u> <u>SOCIETY, CORP.</u>

#### **ARTICLE II PRINCIPAL OFFICE**

THE PLACE IN THIS STATE WHERE THE PRINCIPAL OFFICE OF THE CORPORATION IS TO BE LOCATED REHS 6/6 FRUIT AND SPICE PARK, 24801 187 AVENUE, HOMESTEAD, FLORIDA IN THE COUNTY OF DADE.

#### ARTICLE III. PURPOSE

NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES THE CORPORATION SHALL NOT CARRY ON AY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON (A) BY A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDERSECTION501(C)(3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

IN REFERENCE TO FEDERAL TAX LAW IN ARTICLES OF INCORPORATION IMPOSES A LIMITATION THAT IS INVALID IN YOUR STATE, YOU MAY WISH TO SUBSTITUTE THE POLLOWING FOR THE LAST SENTENCES F THE PROCEEDING PARAGRAPH. UPON THE DISSOLUTION OF THE CORPORATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF THE SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE. ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED BY A COURT OF COMPETENT PURISDICTION OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE IF THE CORPORATION IS THEN LOCATED, EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATION OR ORGANIZATIONS, AS SAID COURT SHALL DETERMINE, WHICH ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.
