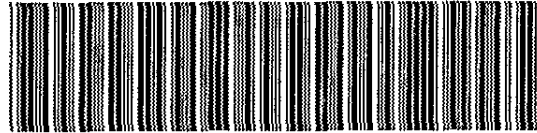

**ARTICLES OF INCORPORATION
OF THE

The undersigned incorporator, for the purposes of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

First Brazilian Free Methodist Church of Destin, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

734 Legion Drive #74, Destin, FL 32541

ARTICLE III PURPOSES

The primary purpose for which it is organized are religious, charitable and educational, and especially:

To conduct religious services, to cultivate social intercourse among its members, and to assist in improving and ameliorating the moral and social conditions of humanity; to purchase, own, sell or dispose of the same, mortgage and lease real estate and other property as may be necessary for the purposes of this incorporation; to receive donations, to receive, manage, take, and hold real and personal property by gift, grant, devise, or bequest, and to sell or dispose of the same, and to do everything necessary, suitable, or proper for the accomplishment of any of the purposes herein enumerated, or which shall at any time appear conducive or expedient for the protection or benefit of this incorporation.

ARTICLE IV TRUST CLAUSE

"In trust for the use and benefit of the Free Methodist Church of North America, incorporated under the name of 'The Free Methodist Church

of North America,' subject to the Book of Discipline, usages, and ministerial appointments of said church, as from time to time authorized and declared; and, if sold, the proceeds shall be disposed and used in accordance with the provision of said Book of Discipline, and the civil law; and in further trust and confidence that in the houses of worship now constructed or that may hereafter be constructed on said promises hereby conveyed, the seats shall be forever free and in further trust and confidence that the said trustees and their successors in office shall permit at all times the preachers who may be duly authorized according to the Book of Discipline of the said Free Methodist Church, to hold religious services in said houses of worship according to said Book of Discipline."

ARTICLE V MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected is:

As determined by the Book of Discipline of the Free Methodist Church of North America from the membership of the local church. The Directors are elected by the members of the local church.

ARTICLE VII DISSOLUTION

In the event of dissolution, the residual assets of the corporation will be turned over to the South Atlantic Conference of the Free Methodist Church of North America.
