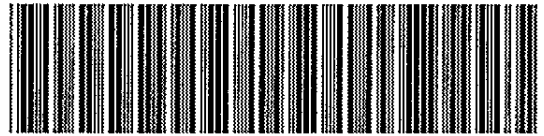

ARTICLE I NAME

The name of the corporation shall be: The Thais Council, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The Thais Council is established to advance and enrich the lives and experiences of historically disadvantaged people through coaching, exploration, exposure to new ideas and self-reflection.

The Thais Council is organized exclusively for charitable, literary, and educational purposes, including for such purposes, the making of distributions to organizations that qualify under section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

No proceeds of the corporation will enrich any individuals except that reasonable compensation may be paid for services to the corporation. If the corporation is dissolved, any assets remaining will be distributed to another corporation serving a similar purpose and qualifying as a tax-exempt, charitable organization under the provisions of 501(c)(3) of the Internal Revenue Code.
