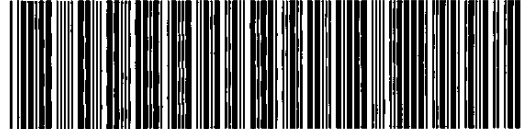

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the corporation is **PINECREST RESIDENTS ASSOCIATION INC.**

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation is **12600 S.W. 81 Ave., Pinecrest, FL 33156.**

**ARTICLE III: PURPOSE**

**The purpose of this non profit corporation is to preserve and protect te quality of life in the village of Pinecrest, Florida.**

**ARTICLE IV: QUALIFICATION**

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.
