## AMENDED AND RESTATED ARTICLES OF INCORPORATION OF

#### HEALTH NEWS FLORIDA INC.

(a Florida Not for Profit Corporation)

HEALTH NEWS FLORIDA INC. (the "Corporation"), a corporation organized and existing under and by virtue of Chapter 617, Florida Statutes, as amended (the "Act"), does hereby certify that:

- A. The Amended and Restated Articles of Incorporation set forth herein were duly adopted by the Board of the Directors of the Corporation on December 2, 2011. The number of votes cast for the amendment were sufficient for approval.
- B. The Articles of Incorporation of the Corporation, originally filed on December 26, 2006, under the name Florida Health News Inc., as amended on March 26, 2009, are hereby amended and restated in their entirety as follows:

FIRST: The name of the corporation is HEALTH NEWS FLORIDA INC. The principal office and mailing address of the corporation shall be located at 2419 Dartmouth Avenue North, St. Petersburg, Florida 33713. The address and location of the corporation may be changed from time to time as directed by the Board of Directors.

SECOND: The period of its duration is perpetual.

THIRD: The corporation is organized and shall be operated exclusively for charitable, literary, educational and/or scientific purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code. Such purposes shall include but shall not be limited to serving the public benefit by furthering citizens, access to health information on state and local health issues in a way that preserves the traditional values of journalism for independence and objectivity, with a freedom from conflicts of interest and by supporting a commitment to public service through explaining complex health issues to the public and mass media through various electronic channels for creating and distributing content that furthers the health, education, and civic needs for the benefit of the citizens of the State of Florida.

FOURTH: Provisions for the regulation of the internal affairs of the corporation, including provisions for the distribution of assets on dissolution or final liquidation, are:

- (a) The corporation shall be a non-profit corporation and shall have no authority to issue capital stock.
- (b) The corporation shall not be a membership corporation, but shall be operated, managed and controlled solely by its Board of Directors.
- (c) The affairs and business of the corporation shall be managed by a Board of Directors having at least three (3) Directors. Each member of the Board of Directors shall have one vote. The directors and officers of the corporation, terms of office, method of selection, respective duties, and all things pertaining thereto, are defined and established by the by-laws of the corporation.
- (d) Without in any way limiting the foregoing, the corporation shall have those powers granted by Chapter 617 of the Florida Statutes.
- (e) No part of the assets of the corporation and no part of any net earnings of the corporation shall be divided among or inure to the benefit of any member, officer or director of the corporation or any private individual or be appropriated for any purposes other than the purposes of the corporation as herein set forth; and no substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation except to the extent that the corporation makes expenditures for purposes of influencing legislation in conformity with the requirements of Section 501(h) of the Internal Revenue Code; and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation or the by-laws of the corporation, the corporation shall not carry on any activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (2) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
- (f) Amendments to these Articles of Incorporation may be made by the Board of Directors as prescribed by law and the Bylaws of the corporation.
- (g) Except as otherwise provided by law, the corporation may at any time dissolve by the affirmative vote of a majority of the Board of Directors. Upon the liquidation or dissolution of the corporation, after payment of all of the liabilities of the corporation or due provision therefor, all of the assets of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or shall be distributed to a federal, state or local government, for a public purpose.

(h) In the event that the corporation is a private foundation as that term is defined in Section 509 of the Internal Revenue Code, then netwithstanding any other previsions of the Articles of Incorporation or the by-laws of the corporation, the following provisions shall apply:

The corporation shall distribute the income of each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code.

The corporation shall not engage in any act of self dealing as defined in Section 4941(d) of the Internal Revenue Code; nor retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code; nor make any investments in such manner as to incur tax liability under Section 4944 of the Internal Revenue Code; nor make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code.

- (i) Except as may otherwise be required by law, the corporation may, at any time, by the affirmative vote of a majority of the Board of Directors, merge or consolidate with or into any corporation in such manner that the surviving corporation is organized and operated exclusively for charitable, literary, educational and/or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code and qualifies as an exempt organization under Section 501(c)(3) of the Internal Revenue Code.
- (j) All references herein: (i) to the Internal Revenue Code shall be deemed to refer to the Internal Revenue Code of 1986, as now in force or hereafter amended; and (ii) to particular sections of the Internal Revenue Code shall be deemed to refer to similar or successor provisions hereafter adopted.

FIFTH: The street address of the registered office of the corporation is 2419 Dartmouth Avenue, North, St. Petersburg, Florida 33713 and the name of its registered agent at such address is Carol Gentry.

SIXTH: The Corporation has no members or members entitled to vote on these Articles of Amendment. Therefore, because these Articles of Amendment contain an amendment to the Articles of Incorporation which does not require member approval, these Articles of Amendment have been adopted by the Board of Directors.

The date of each amendments adoption is December 2, 2011.
