As per our telephone conversation enclosed is a completed UBR form for 2001 and a check for \$376.25 for the Annual Report filing fee for the years 1996, 1997, 1998, 1999, 2000, and 2001 and for a certificate of status. As per you suggestion the following is an explanation as to why the annual reports were not timely filed and a written request for waiver of the reinstatement fee.

The above mentioned corporation is a nonprofit corporation that feeds persons in need of food. As such the corporation is managed by volunteers. The turn over in management was extraordinary over the last six years. Those who are in charge try to focus on feeding those in need of food. During the transition between management teams the corporation relocated and an address change was made with the Florida Department of State Division of Corporations. It appears that the address was not correctly changed

by the department of corporations, because I was told via telephone the departments records reflect the city, where the above mentioned corporation is located, to be Miami Beach. The abovementioned corporation is in fact located in Coconut Grove.

At the point where the annual report was not received had to be after one of the transitions in management and the new management team must not have been aware that an annual report had to be file since they never received an annual report while they were in charge. Management first became aware that the corporation was administratively dissolved when a certificate in good standing was requested. Once management was told that the abovementioned corporation was administratively dissolved I was contacted to have the above mentioned corporation reinstated.

Florida Food For All Inc. exits on donation and a lot of the donation are not money. It may get food, paper plates, and other items use to help feed persons in need of food. Florida Food For All Inc.'s budgets all cash donations and there is never enough cash to cover the budget. Over the last few weeks Florida Food For All Inc. was able to get donations to cover the late annual report fees, most people don't like to give donations to cover government fees. Under these circumstances Florida Food For All Inc. by and though the under signed attorney request that the reinstatement fee of \$175.00 be waived.

Raising the \$369.00 has created a hardship in that donations had to be use to pay the annual report fees. It was a an oversight on the part of Florida Food For All Inc. and it is understood that

the fees must be paid. However, as to the reinstatement fee it is something that has come about due to a mistake. \$175.00 can feed a lot of persons in need of food.

Therefore, the wavier is requested so that money can be used to further Florida Food For All Inc.'s purpose and with the assurance that this will not happen again.
