**ARTICLE XIII - GENERAL DISPOSITION**

Be it also resolved, to ADD to the amendment in the Articles of Faith & Government, Article XIII General Disposition the following:

**AA. The local church as part of the Council**

1. Local churches whose names appear on our registers, as a result of faithful service of the ministers and representatives of the general assembly and these churches, having been received as such representatives, come to form part of the general assembly. As such, it is not recognized nor exists the right for any local church, as one, to separate from the General Assembly. Furthermore, the members that are disloyal to the government and pronounced teachings by the general assembly or should have disorderly conduct shall be judged individually.

BB. Receiving of churches or associations of churches

1. When a church or association of churches wish to affiliate to the church to form part of the Council, that church or association shall follow the Rules & Constitution in the Articles of Faith & Government.

2. The members of this Council will remain in their positions until the majority has named their successors through an election. Also this Council shall be the depository of the title of the property and shall have in their possession all titles of property; and in reference to the local church, the council shall direct and control all property that the local congregation possess. All referenced property shall be used, administered and controlled for use or benefit of the church of God.

3. If any church should leave the affiliation with the council, the Council shall retain the property for the Church of God and shall transfer the local property for the use, disposition and benefit of the Church in this state; also the council can use the property and the benefits derived from the sale of said property, to fund a new church or promote one that already exists.
