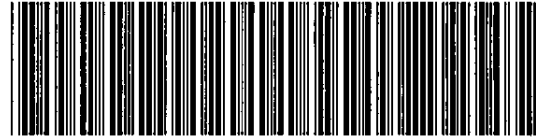

**ARTICLE III PURPOSE:**
