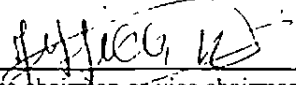

ARTICLES OF INCORPORATION

ARTICLE I :

The name of the Incorporation shall be SISTUHS, Incorporated and these bylaws will be governed by the National Board of Directors.

ARTICLE II:

The principal office and mailing address of the organization shall be:
9378 Arlington Expressway Ste. 347
Jacksonville, FL 32225

The second office, if deemed necessary, shall be at the discretion of the National Directress.

ARTICLE III:

The specific purpose(s) for which the Corporation is organized is (are):

1. Promote spiritual growth.
2. Promote personal growth and develop knowledge of thyself.
3. Promote a positive image of African-American women and anything that positively enhances the survival and well-being of African-American women.
4. Seek guidance from Elder African-American women.
5. Foster an environment amongst ourselves that is conducive to learning about the history, and the role African-American women have played and continue to play in developing this and other nations.
6. Develop local leadership to respond to community needs, particularly those of African-American women.
7. Provide moral and educational guidance to other young African-American women in the community.
8. Provide unity among People of Color.
9. Provide opportunities to educate ourselves, as well as the community, on political issues that affect the well-being of African-American women.
10. Provide encouragement and support to African-American men.

These objectives are upheld by the provisions set forth in the official National Constitution of SISTUHS.

SISTUHS, Incorporated is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLES OF INCORPORATION

ARTICLE IV:

1. The manner in which the Directors are elected or appointed is:
2. Applications for candidacy for the National Board of Directors shall be submitted to the National Board of Directors by April 15th.
3. Active Members that are in good standing for at least two (2) years prior to April 15th shall be eligible to serve on the National Board of Directors.
4. The National Board of Directors is elected by the majority votes cast.
5. Elections for the National Board of Directors will be held every two (2) years at the National Conference, unless there are vacant positions.
6. Candidates must present a 3-5 minute speech at the National Conference defined in the National Board of Director's Manual.
7. Elected Candidates must be publicly installed at the National Conference.
